**DSA JUDGE'S LIAISON DUTIES:**

- Is a voting member in good-standing with the club.
- Contacts the judges voted in by the membership, to obtain their judging contract terms and pass that information back to the specialty committee for review. If the terms are acceptable to the committee then: 1) Enters the judge's name, contact information, assignment and terms into the standard DSA judges contract template, 2) Signs the contract on behalf of DSA, 3) Sends the contract to the judge for their acceptance, and 4) Provides a signed copy of the contract to the specialty committee.
- Is the single point of contact for the club, if the judge has any follow-up questions.
- Be the club host/greeter/club contact for the judge during the course of the show weekend.
- Is **NOT** allowed to show his/her dogs at this specialty, nor are the families that he/she co-owns dogs or bred.

## ENTRY FEES AD POLICIES

"A recording fee of 50 cents and a \$3.00 AKC Event fee per entry will be required for each dog entered at any Licensed or Member Club Show or Obedience Trial. A \$3.00 Event Fee will be required for each entry of each dog in the Rally Trial. This recording fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the recording fee is to be collected on the first entry only" Ch. 11, Section 2, AKC Dog Show Rules. When a dog is entered in more than one class the highest-priced class is considered the first entry.

### ATTENTION:

- Rally entries cannot be considered the additional entry of the same dog if the dog is entered in the specialty show or obedience trial.
- Entries in Puppy Sweepstakes must be entered in a regular class at this show.
- Entries in Veteran & Working Sweepstakes do not have to be entered in a regular class at this show.
  - Twelve to Eighteen Month Class is an adult class and requires an adult entry fee.
  - Novice Class and the Amateur-Owner-Handler Class are not offered at this show.
  - See Obedience & Rally sections for refund policy for bitches that come in season after closing date.

No entry may be sent by any method that requires a signature for delivery.

Exhibitors who list a legible email address on the entry form will receive an email confirmation of entry received. Contact the show secretary if you do not receive a confirmation of entry received within a reasonable time.

ALL EXHIBITORS MUST SUBMIT FEES IN U.S. FUNDS.

Entry fee(s) will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of a Show Committee. Refunds to exhibitors who miscalculate their entry fees, and overpay, are at the discretion of the DSA. Post-dated checks and returned checks do not constitute a valid entry fee. The DSA will add a collection fee of \$25.00 to the amount of each returned check. Subsequent returned checks from the same exhibitor(s) may result in them being put on a CASH-ONLY basis.

No entry fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strike, and/or any other cause beyond the control of the Club or Show Secretary.

No entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures. There are no refunds for duplicate entries. The Show Secretary will make an effort to find duplicate entries, but if an entry has been processed, no refund will be made.

Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. Owners and agents are responsible for errors in completing entry forms. Whoever may make such errors, no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.

The Denver Samoyed Association, Inc. does not agree to arbitrate claims as set forth on the Official American Kennel Club Entry Form for this event.

The owner or agent assumes all responsibilities for wrong or incomplete information on the entry form. Entries will not be accepted without fees and signatures. Entries must be made on an Official AKC Entry Form, or photocopy of the Official AKC Entry Form with the Agreement and Rules on the reverse side, or they cannot be accepted. Agents may indicate their name on entry forms for inclusion in the catalog provided they are at least 18 years old and neither own nor co-own the dog. Show Site Layout and Usage Rules: The Multi-Purpose Barn is divided into two separate buildings connected by a covered breezeway.

- South building – Grooming area
  - Dryers are allowed in this building.
  - There is ample grooming space. Roping off an area or saving spaces will not be allowed unless authorized by the show committee. This will be strictly enforced.
  - Crates must be stacked whenever possible. Grass mats, tarps, ex-pens and dog playpens are not allowed.
- North building – Competition area, contains a 50' x 45' fully matted show ring, to be used for all competition events.
  - Dryers are NOT allowed in this building.
  - A crate staging area will be available and marked in the north building. Exhibitors may use this area before & immediately after their class is judged. Grooming, dog dryers, scissoring, etc. will not be permitted in this area.
  - Exhibitors will be asked to remove their dogs if they are barking excessively in the staging area.

RV Parking is allowed at the fairgrounds in lot # 1 next to the Multi-Purpose Barn. No water, sewage or electrical hook-ups are available.

### Compliance Rules:

- No baby strollers in the buildings.
- No exercise pens in the buildings.
- No unentered dogs will be allowed on the grounds during show hours.
- No dogs will be allowed in the buildings overnight.
- No drilling nor intensive or abusive training of dogs on the show grounds will be permitted.
- No double handling will be permitted at these shows. Individuals who attempt to double handle from outside the ring will be subject to action by the Show Committee.
- Dogs must be in control at all times. This includes the use of Flexi-leashes.
- Dogs must be removed from the show site following "Best in Specialty Show".
- Exhibitors are required to clean up after the dogs that they are exhibiting or which are under their care or control. This requirement includes both while in the ring or at any location on our show site. **This is a self-cleaning dog show.**



DSA reserves the right to remove any animal in distress from a parked vehicle or crate in any manner necessary. DSA solely determines if said animal is in distress. All persons attending this dog show hereby waive any claim for damages against the club for such removal.

Dogs need be present only for scheduled judging, and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club, nor the Show Secretary will be responsible nor obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings

Unawarded Sweepstakes class placement prize money, from classes with less than four entries, will be divided equally among the Sweepstakes class placements. The division of unawarded prize money will not include prize money not awarded due to absences.

Trophy Information: The DSA reserves the right to substitute a prize of equal or greater value. All trophies must be claimed the day of the show. None will be mailed.

## ROUTES TO THE SHOW

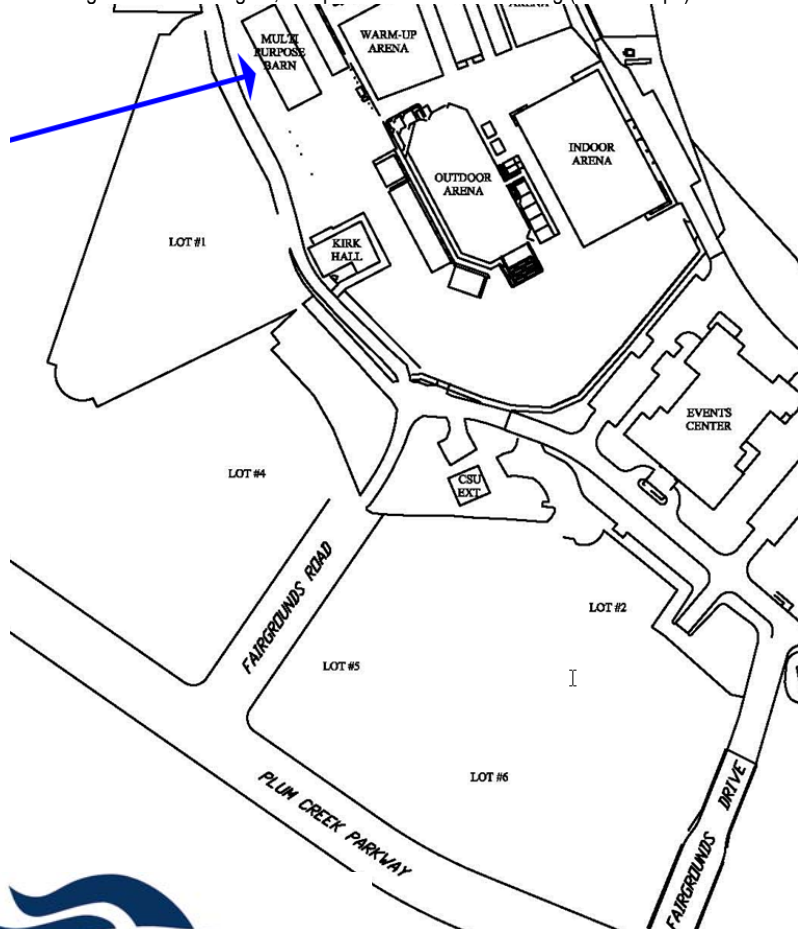
Douglas County Fairgrounds – 500 Fairgrounds Road, Castle Rock, CO 80104

The fairgrounds are centrally located between Denver and Colorado Springs, one mile east of Interstate 25 at Castle Rock Exit 181.

Directions from the North: Take I-25 south to the Plum Creek Exit #181. Turn left at the signal onto Plum Creek Parkway. Go east on Plum Creek Parkway, approximately one mile to Fairgrounds Road (the 3rd signal light). Turn left on Fairgrounds Road.

Directions from the South: Take I-25 north to the Plum Creek Exit #181. Turn right onto Plum Creek Parkway at the signal light. Go east on Plum Creek Parkway, approximately one mile to Fairgrounds Road. Turn left on Fairgrounds Road

Continue on Fairgrounds Road and turn left into Gate A and proceed to the Multi-Purpose Barn unloading area located on the west side of the building. After unloading, continue on road and take first left through the chain-link gate, and park in Lot # 1. RV Parking (no hook-ups) is in Lot # 1.

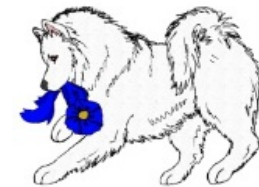

**AKC NATIONAL OWNER-HANDLED SERIES COMPETITION**

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants\*\* to professional handlers may not exhibit the dog in any competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

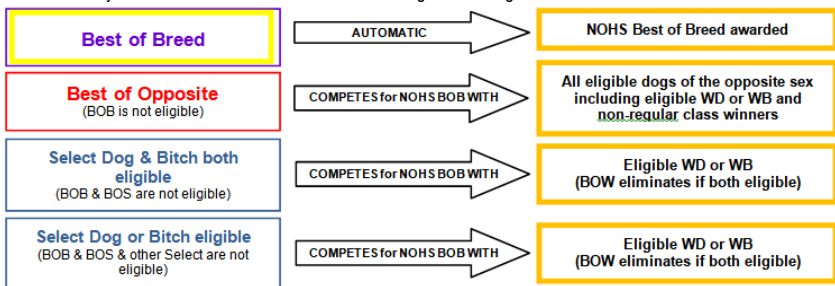
*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

*\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any during the cluster/weekend.*

**Designating NOHS Best of Breed**

Once the judge has awarded BOB/BOV, BOW, BOS and Selects

- Steward should compare the eligible entries against the awards
- Advise the judge of the awarded dogs indicated as eligible to compete (\*) in the AKC National Owner-Handled Series
- Determine by the flow chart which entries remain in the ring for the designation of NOHS Best of Breed
